
Best for the World for Customers 2022

Workers

We're proud to be a staff-owned business, and we do everything we can to invest in our people and build a great working culture at EQ.

Career development

Working to the highest professional standards is core to our business, and we actively support employees to become qualified in their chosen careers through funding exams, allocating study leave and paying membership fees for different professional bodies (e.g CFA, CII, CISI, LIBF).

57% of our Financial Planning staff have achieved Chartered status (CII or CISI), with others on track to achieve this in next 2-3 years. 73% of our investment team have obtained CFA Charterholder or CISI equivalent.

Staff incentives

All staff are given the chance to become shareholders after one year in the business. 60% of staff are currently shareholders and receive regular divdends.

In addition to being an accredited Living Wage Employer, all our staff are also eligible for our bonus scheme, and this year we've enhanced our parental leave policy to support all our working parents. After two years of remote working during the pandemic, we've evolved a hybrid working model which we see as crucial to our success and continued growth.

Access to employment

We partner with the Resurgo Spear programme, a charity that helps unemployed young people facing barriers to employment. Resurgo provides careers advice, interview prep and coaching & mentoring to candidates as well as working with external firms on internship and full time opportunities that 'Spear Graduates' can proceed into.

We achieved our target of 35% women in senior leadership roles by April 2022. We are now looking to increase this to 40%, to be achieved by 2026.

10,000 Black Interns Programme



We are founding members of this initiative and supported our second internship during the summer of 2022.

Environment

EQ has been a carbon neutral business since 2020, when we measured and offset our carbon footprint for the first time.

Pledge, plan, proceed, publish

EQ is a member of the B Corp Climate Collective, committing to net-zero emissions by 2030 – 20 years ahead of the targets set in the Paris Agreement.

2021 was our second year of measuring EQ's operational carbon footprint. This included:

- Purchased electricity and gas (33 tonnes)
- Purchased goods and services (233 tonnes)
- Business travel (2 tonnes).

We are committed to reducing these as far as possible, and offsetting any remaining emissions via schemes that remove carbon from the atmosphere when that is possible.

Our investment footprint

As investment managers we have an obligation to manage climate risks across all our portfolios.

Most portfolios are already managed with an explicit aim to demonstrate lower financed emissions versus benchmarks, and we are already engaging with investments on net-zero plans.

This year we launched an online carbon calculator tool that our investors can use to measure the emissions associated with their EQ investment portfolio.

Our medium term goal is to integrate netzero investment targets into our portfolio management, fund research, monitoring and engagement processes where appropriate. We are currently working on a climate strategy and targets by applying emerging best practices.

Carbon neutral since 2020

EQ Investors is proud to be a carbon neutral business. We offset our 2021 carbon footprint – 268 tonnes of CO_2 – through a partnership with Respira. Through verified carbon credits (by VCS), we supported a reforestation project in Ghana, helping expand back to the previously healthy forest cover that has been degraded through overexploitation and agricultural land-use.

Going beyond offsets

Offsets are never going to be enough to avert the climate crisis, and are no substitute for emission reductions. As a consequence, we made additional voluntary donations in 2022 to two charities, Carbon180 and ClientEarth,who are working to deliver systemic changes through environmental litigation and policy advocacy.
