EQ cannot provide you with investment advice in connection with this service and we will act only upon your instructions, or upon instructions authorised by you, following advice from your Financial Adviser.

This document forms part of our agreement with you and should be read along with EQ & Pershing terms of business as well as the suitability report provided by your Financial Adviser.

This agreement is between:

1. You, the investor, as the client to whom we agree to provide the agreed services and whom enters into this Agreement with Us, and

2. **EQ Investors Ltd**, incorporated and registered in England and Wales with company number 07223330, whose registered office is at 6th Floor, 60 Gracechurch Street, London, EC3V OHR.

#### **Direct Debit Guarantee**

If you request Pershing Securities Limited to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
